The applicant is strictly forbidden to interfere with or allow other to interfere with the meters or other appliances of the Company.

The applicant agrees to pay a monthly minimum charge at the Company's current rate whether any water is consumed or not.
The applicant agrees to notify the System when the applicant desires said service discontinued and agrees to pay for said service for a reasonable time after each notice, in order to permit the System to read or remove meters and render bill.

It is further understood that this application or agreement is subject to the Standard Rules and Regulations of the System, on file and open for inspection at the office of the System, and said rules and regulations are hereby made a part of this agreement.
